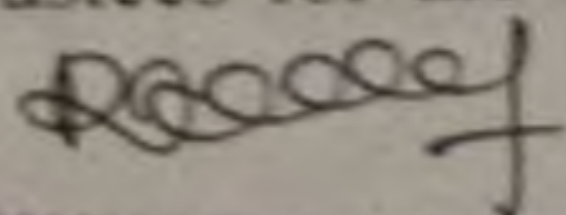

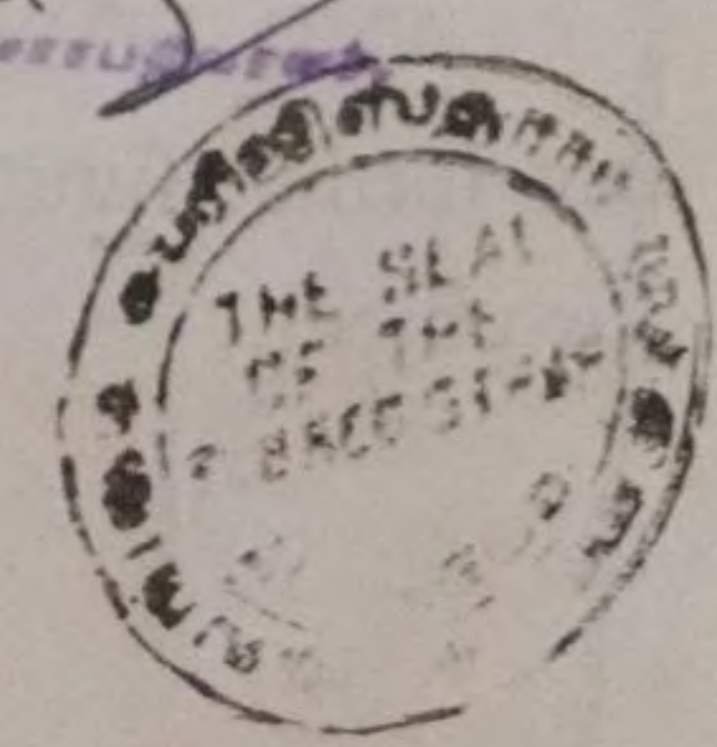

1. Name of the Trust

2. Registered Office

The Registered Office of the Trust shall be at Kovilur, Alangudi Taluk, Pudukkottai District, Tamil Nadu.

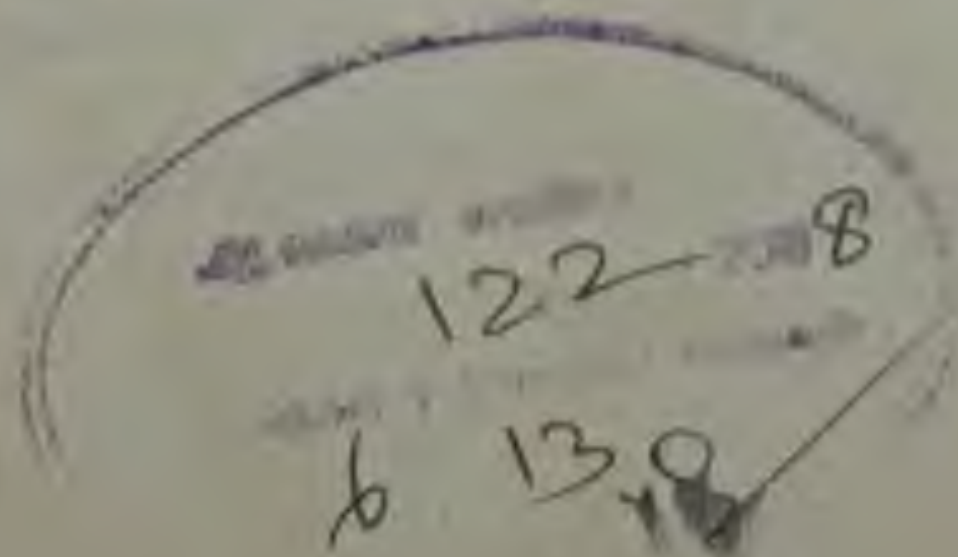
The Registered Office of the Trust may be shifted to any other Place/Places and may branch or branches may be opened as the Board of Trustees may decide from time to time.

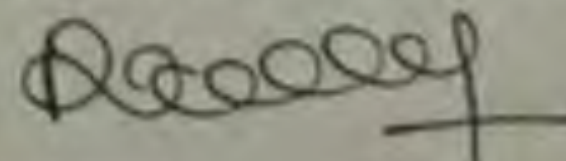
3. Purpose and Objects of the Trust

The following shall be the main objects or the Trust to start with and the Board of Trustees on behalf of the Trust shall have the power to add, modify, delete or include one or more objects as may be decided upon by them from time to time.

Arumugam Educational and Social Trust is formed with the noble object off establishing schools and colleges in rural and urban areas so as to enable the poor to get good education and to improve their standard of living and to do social activities needed for our people.

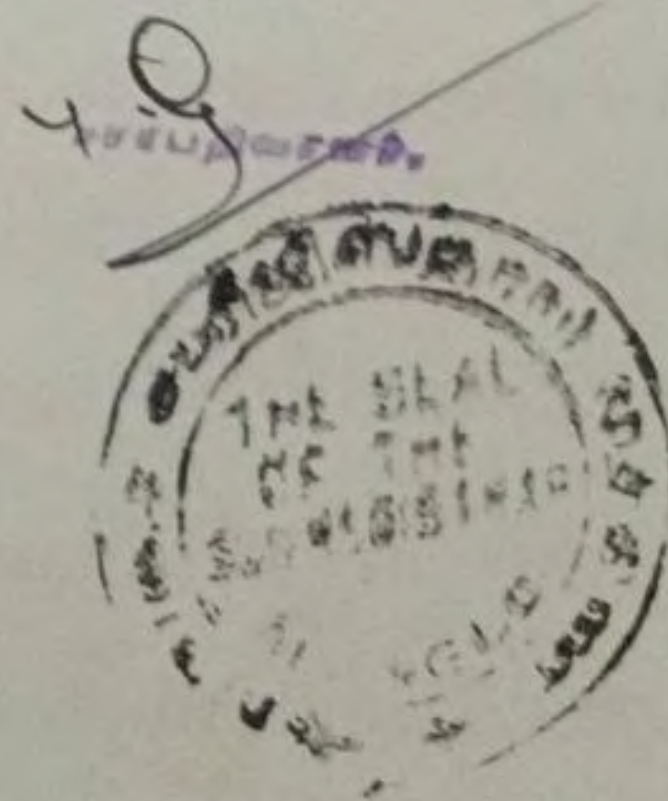


5. To provide facility to rural youth for getting higher education and conduct programmers for creating awareness about self-employment.
6. To conduct AIDS awareness camp.
7. To start night schools in rural area.
8. To educate people to know about Govt. Small savings schemes and to open accounts in co-operative societies, post offices, Banks, etc.,
9. To create Religious integrity among different people belongs to various caste, creed, race, etc.,
10. To conduct programmers in schools to know about Religious integrity and to form secular society.

17. Arranging seminars for importing and exporting of products which are produced through self employment.

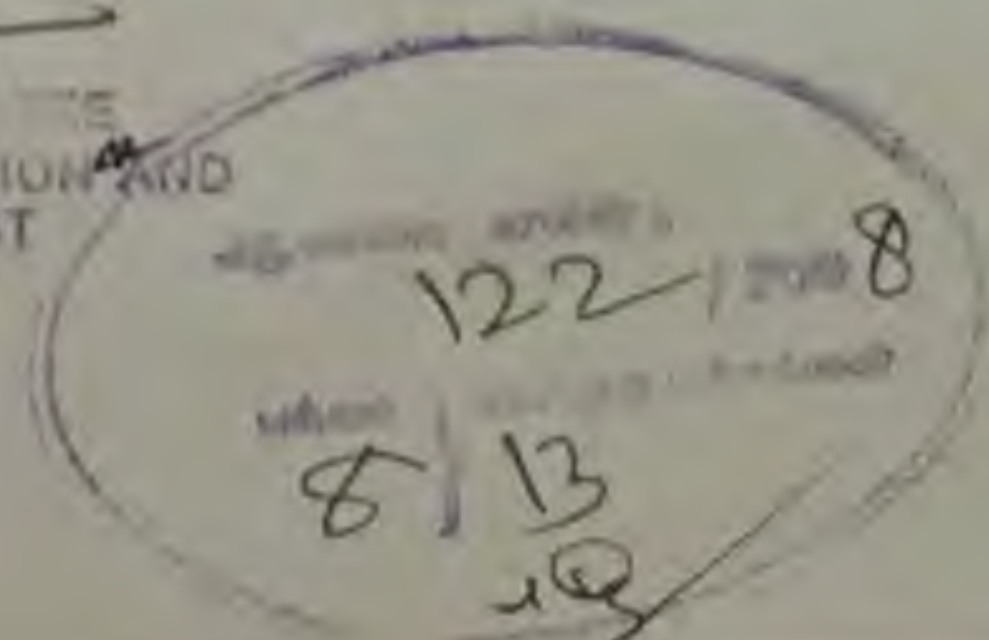

Now running the Educational institution.

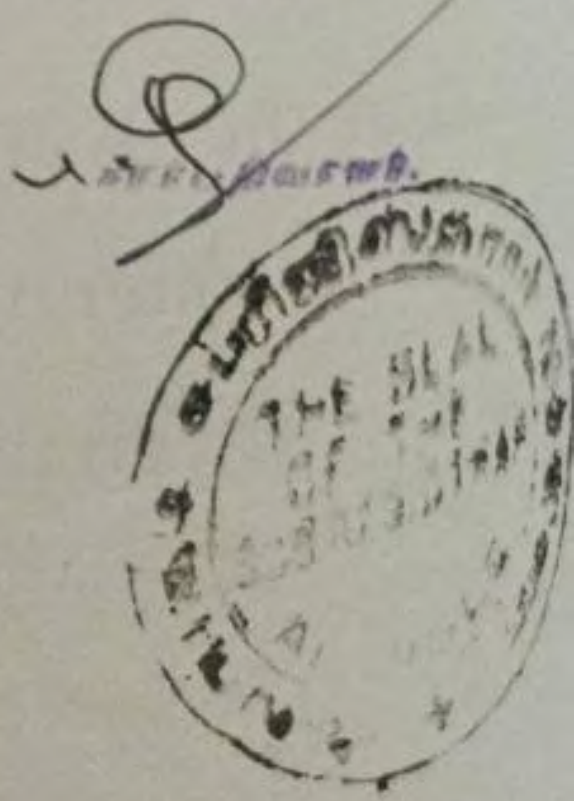
4. PROJECT COMMITTEE

5. CONSTITUTIONS AND ADMINISTRATION OF TRUST:

- (i) This Trust shall be administered by the Founder Trust Thiru.A.VIJAYAKUMAR, who will also act as the Managing Trustee with the help of the Board of Trustees.
- (ii) The initial Board of Trustees will consist of the following persons.

(i) MANAGING TRUSTEE:

The Founder Trustee Thiru.A.VIJAYAKUMAR, will act as Managing Trustee the Managing Trustee will administer the Trust with the help of other Trustees.

(ii) FINANCIAL /JOINT MANAGING TRUSTEE:

The permanent Trustee Thiru.G.CHIRTAVALLI, will act as Financial and Joint Managing Trustee. She will administer the Trust in the absence of Managing Trustee and will do all acts as per the guidance of the Board of Trustees. She will maintain Books of Accounts and other records.

(iii) EXECUTIVE TRUSTEE:

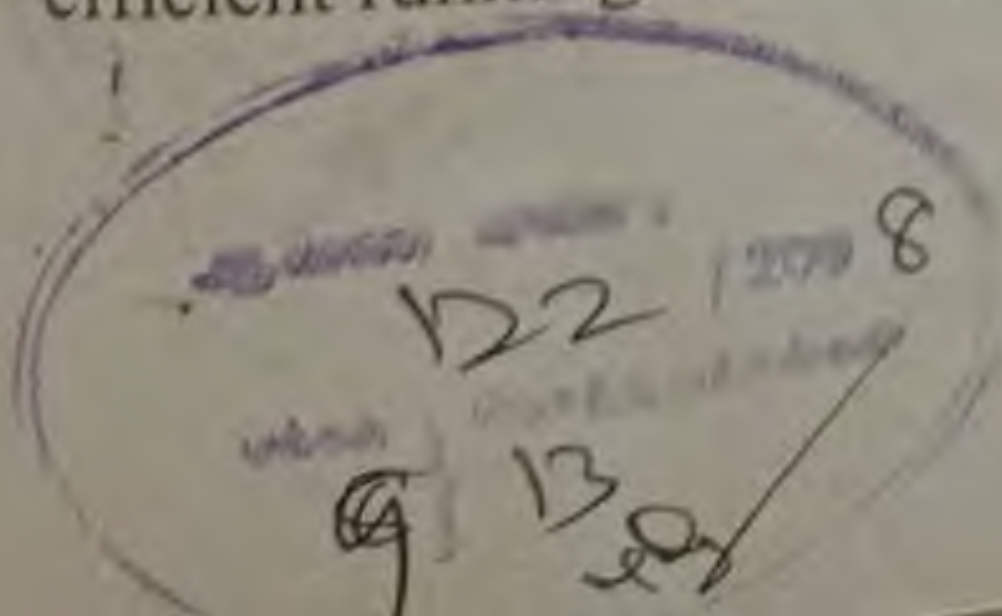
All the trustees will act as executive trustees.

6. POWERS:

POWERS OF MANAGING TRUSTEE:

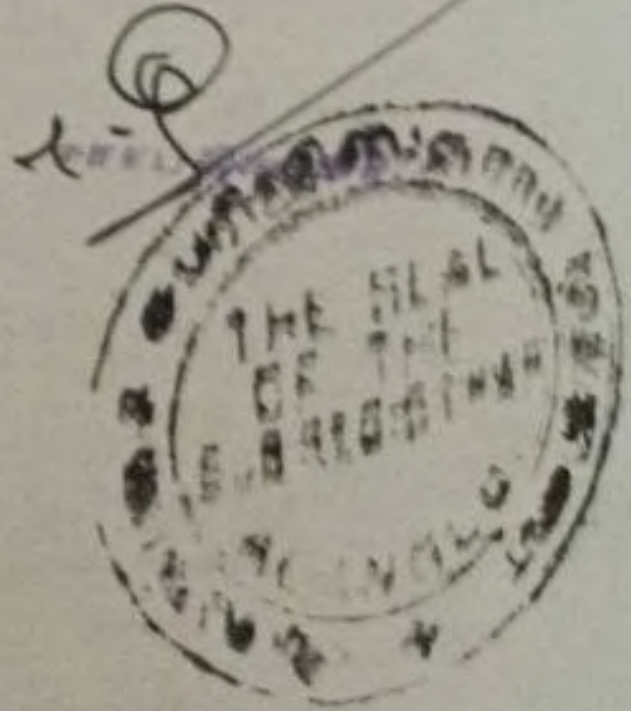
The Board of Trustees shall have the right to appoint other persons as Trustees and also co-operative persons in the vacancy caused in the post of Trustees.

- (i) All contracts, documents requiring the signature of any person in order to be binding on the Trust shall bear the signature of the Managing Trustee and Financial Trustee.
- (ii) The Managing Trustee has the power to appoint required staff for the efficient running of the Trust and for achieving its other objects.

(iii) The Managing Trustee shall have full power of Management of the Trust properties and funds and he will have full control over the finance of the Trust.

(iv) To institute, prosecute, defend and compromise all action and proceedings before the Government court, Tribunal and other Authorities including suits, appeals, reviews and revisions and to represent the Trust before them.

POWER OF JOINT MANAGING TRUSTEE:

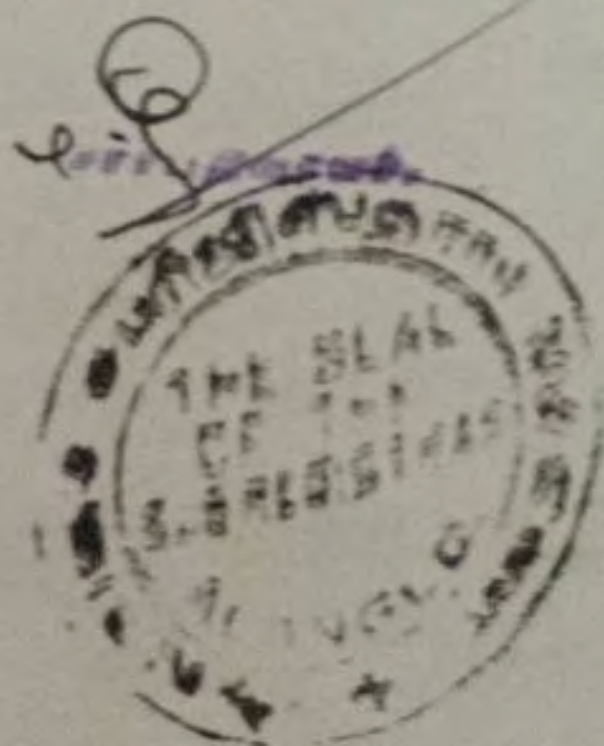
The Joint Managing Trustee will administer the Trust in the absence of Managing Trustee and will do all acts as directed by the Managing Trustee.

1. The Board of Trustees shall be entitled to let out its building or portions thereof as is not required for the purpose of the Trust and also other immovable properties which form part of the Trust on such terms and conditions as they deem proper.
2. Every Property of the Trust movable or immovable shall be kept in the name of the Trust.
3. The Trust shall be entitled to frame rules and regulations for the conduct of their business and for the administration of the Trust and for carrying out its objectives and for the maintenance and conduct of its project, its activities and the facilities provided therein and to alter, amend or vary such rules and regulations from time to time as they may deem proper. Such rules and Regulations shall not be in contravention of the provisions of the Income Tax act in this respect.

5. BANK ACCOUNT:

The Board of Trustees shall open one or more bank Account / Accounts in the name of the Trust and shall be operated by only Managing Trustee. The Board has power to borrow money from bank, financial Institutions or from the public to achieve its objectivities on the signature of Managing Trustee.

6. MEETINGS:

The meeting of Board of Trustees shall be convened once in a month.

7. QUORUM:

Two Trustees of Board of Trustees shall be quorum required, for the Board Meeting.

8. OTHER RULES AND REGULATIONS:

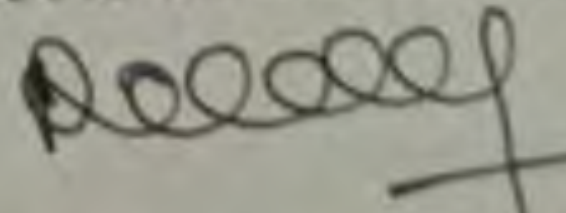
- (i) The funds of the Trust will be invested only in accordance with the provisions of Section 13(1) (d) read with Section II (5) of the Income Tax Act.
- (ii) The Trust formed shall be IRREVOCABLE.
- (iii) The Trust will maintain proper books of accounts regularly and accounts will be audited by a Qualified Chartered accountant every year.
- (iv) The Income and Funds of the Trust will be solely utilised towards the objects and no portion of it will be utilised for payment to Trustees by way of profit, interest dividends, etc.,

POWERS OF FINANCIAL TRUSTEE:

The Financial Trustee of the Trust shall maintain transactions and accounts of the Trust and also the Institution run by the Trust subject to the orders of the managing Trustee.

POWERS OF THE EXECUTIVE TRUSTEES:

The Executive Trustee of the Trust shall have power, subject to the orders of the Managing Trustee, to do all such things as are necessary or expedient for the management of the affairs of the Trust or which may be conducive to the attainment of the objects of the Trust.

POWERS OF THE BOARD OF TRUSTEES:

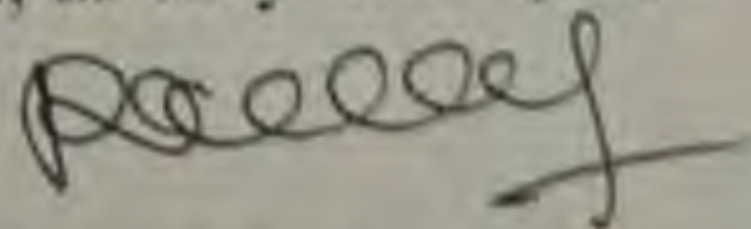
1. The Board of Trustees shall get in and collect the income, interest and dividends of the "TRUST FUND" from time to time and shall therefrom pay in the first instance all the costs, charges and expenses and shall hold the net balance of the income and the Corpus of the Trust Fund for the objects of the Trust here before mentioned.

2. For the purpose of carrying out the objects of the Trust and for providing the facilities and undertaking the activities as mentioned above the Board of Trustees shall be entitled to utilise the funds of Trust as well as its income in such a manner as they shall in their prudence and judicious discretion deem it proper.

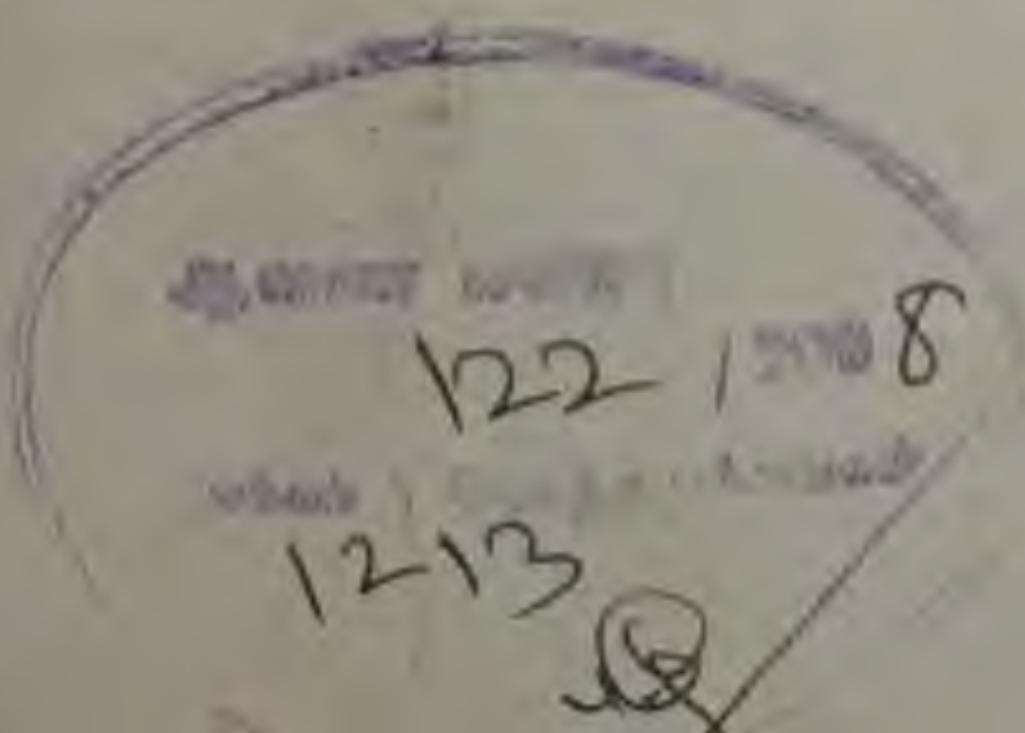
3. The Board of Trustees shall be entitled to receive upon such terms and conditions as they may deem fit, donations, gifts subscription on cash or in kind and to collect funds by public or private appeal for carrying out the objects of the Trust.

4. For the purpose of carrying out the objects of the Trust, the Board of Trustees shall be entitled to purchase and / or to construct one or more building or buildings or purchase other immovable property or properties suitable for the functioning of the project. The Board of Trustees shall also be entitled to purchase or acquire furniture, equipments and all other movable properties as may be necessary or proper for maintaining and conducting the project and for providing the facilities and undertaking the activities at such place as may be decided upon and otherwise to give effect to the objects of the Trust.

5. The Board of Trustees shall have power to raise loans or obtain advance for the purposes of the Trust with or without security and upon such terms and conditions, as they deem proper.

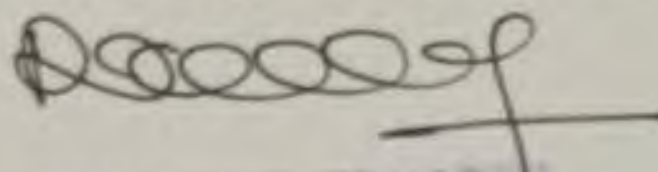

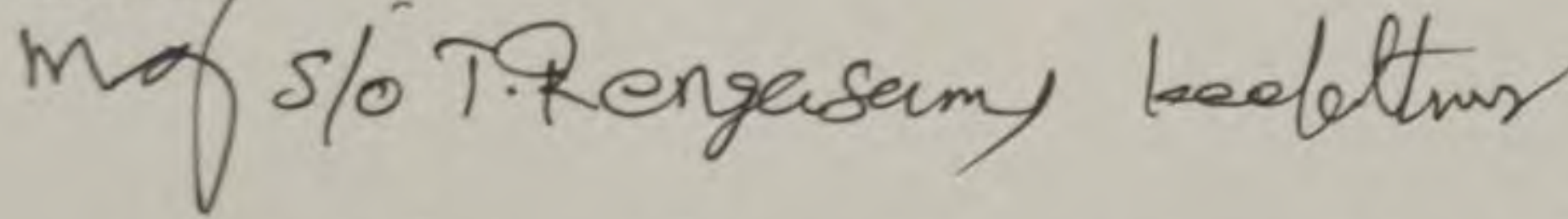

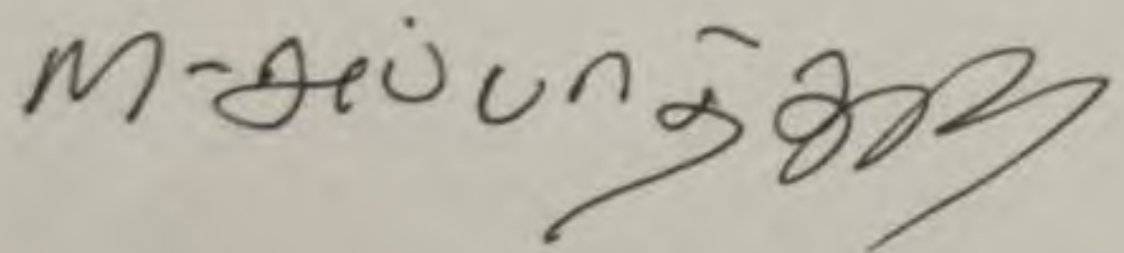

 10. The Trust will not carry out any activity with the intention of earning profit.

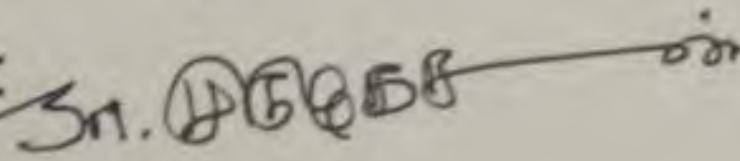

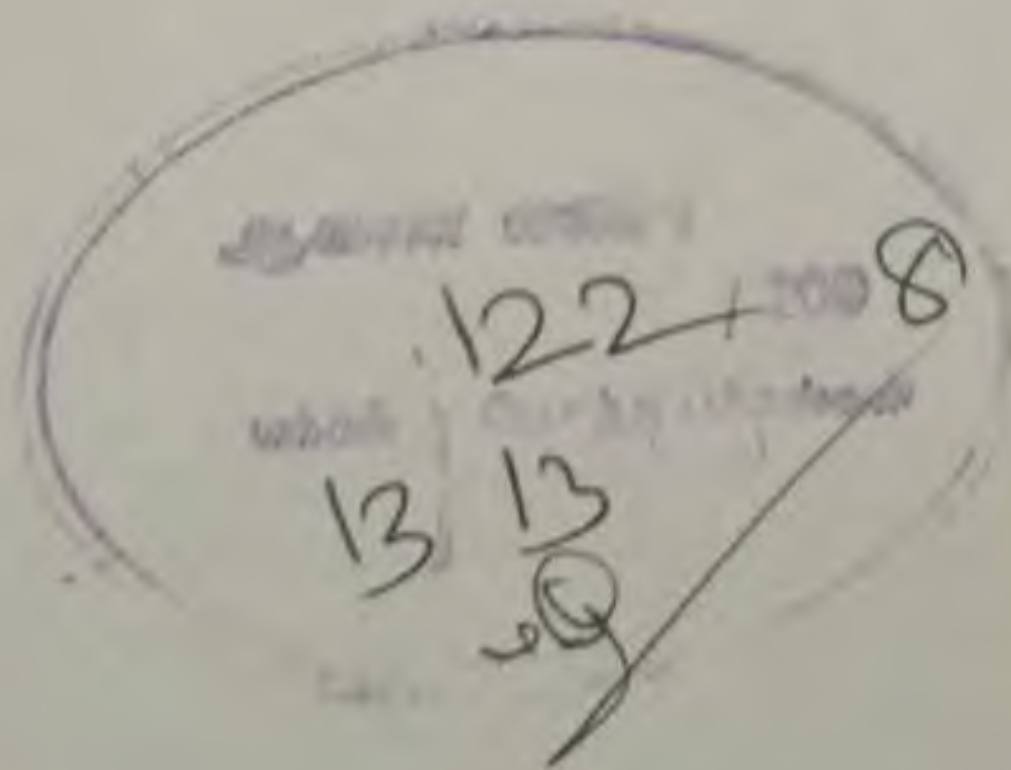
